# **Privacy Notice**

# The Hill Street Youth and Community Centre



This notice explains how The Hill Street Youth and Community Centre uses and protects the personal information that it holds about users and visitors to its website.

This website is wholly funded and run by The Hill Street Youth and Community Centre, (HSYCC) Hill Street, Rugby, Warwickshire CV21 2NB and is registered as a Charitable Incorporated Organisation (CIO) Number 1156128.

#### What is personal information?

Personal information broadly means information that identifies (or which could, with other information that we hold or are likely to hold), identify a living individual.

## What types of personal information might we hold about you?

We may collect and process information about you that you provide by filling in forms or by corresponding with us by telephone, email or accessing our website or social media. We may also collect responses to surveys and feedback forms, enquiries about room hire and services we offer. We may also take photographs but will always ask for your explicit permission before doing so or when sharing them.

We may hold and process any or all of the following personal information about you:

Personal details such as your name, gender, age, date of birth, contact details (your address and postcode, email address, telephone and mobile numbers), health and disability, and other non-personal information.

## Why do we hold this information?

We hold this information because it is necessary for us to administer HSYCC. Without your personal information, we cannot provide the best services we can. We will only use this information to process your requests, to provide you with our services, and to provide you with information relating to our services and all other services which we think may be of interest to you.

#### Security

We will take reasonable precautions to prevent the loss, misuse or alteration of information you give us. We destroy all personal data in a secure manner that retains confidentiality.

#### Where we store your personal data

We store electronic information in password protected files that have limited access, is not shared and has the latest virus protection software which is always kept up to date. We keep back up data files securely offsite. If we keep paper copies, then they are stored securely in a locked facility with limited and controlled access.

Cookie policy we do not use cookies on the www.hillstreetcentre.org website.

Google analytics policy we do not collect visitor data through Google analytics.

## **Mailing List**

At visitor request, we receive requests for additional information. Visitors to our site will provide their names, email address and telephone number for us to be able to make direct contact.
